

**RESOLUTION NO. 5-15**

**A RESOLUTION CONTAINING THE WATER RATE SCHEDULES FOR ALL CLASSES OF CUSTOMERS UTILIZING THE WATER SYSTEM OF THE UTILITIES COMMISSION, CITY OF NEW SMYRNA BEACH, FLORIDA; ADDING A 12" NON-RESIDENTIAL POTABLE WATER RATE TO THE EXISTING RATE SCHEDULES AND IN SUPPORT OF THE OPERATION OF THE EXISTING 12" POTABLE WATER INTERCONNECT BETWEEN THE CITY OF PORT ORANGE AND THE UTILITIES COMMISSION; RESCINDING RESOLUTION NO. 3-10 AND ALL OTHER RESOLUTIONS OR PORTIONS THEREOF IN CONFLICT HEREWITH, AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Utilities Commission, City of New Smyrna Beach, Florida, is obligated and authorized pursuant to the laws of the State of Florida, particularly Chapter 67-1754, Laws of Florida, as amended by and restated in Chapter 85-503, Laws of Florida, to establish and maintain rate schedules for the use of the water system, and to make such other changes in such amounts as are necessary and sufficient to pay the expenses of operating and maintaining such facilities, to provide debt service, funds for necessary improvements, and to honor all requirements of the Utilities Commission; and

**WHEREAS**, after careful examination of the revenues to be received from the operation of the water system and the projected expenditures for operation and maintenance of such system and the funds required for renewal and replacement, and to amortize revenue certificates heretofore issued or to be issued by the Utilities Commission, it was found and determined the attached water system rate schedules are currently in full force and effect; and

**WHEREAS**, the Utilities Commission, pursuant to the Florida Department of Environmental Protection and St. Johns River Water Management District's requests and directives involving sustainment and conservation of water resources and supplies, and specifically regarding the development of interconnections in support of public utilities (potable water and reclaimed water) for various contingencies and such as emergency support during extreme weather events and mechanical infrastructure failures; and

**WHEREAS**, the Utilities Commission has determined it is desirable for each entity to charge their respective rates for use of their products in the operations of the interconnects, and therefore the addition of a 12" potable non-residential water service rate is necessary, and hereby proposes the establishment of the attached rate for this service, and;

**WHEREAS**, the Utilities Commission have reviewed the requested addition of a 12” non-residential potable water rate to the existing potable non-residential water rate schedule and have presented this proposed addition of a monthly charge to the customers of the Utilities Commission, and to other parties of interest at a preliminary public hearing held November 16, 2015, and at a final public hearing held on December 21, 2015, which hearings were duly noticed and advertised; and

**NOW, THEREFORE, BE IT RESOLVED BY THE UTILITIES COMMISSION, CITY OF NEW SMYRNA BEACH, FLORIDA, AS FOLLOWS:**

**SECTION 1:** The rate schedules for potable water remain in effect with no changes except for the addition of a 12” non-residential service rate and that service schedule is revised in accordance with the following attached Rate Schedule "A" incorporated herein by reference and made a part of this Resolution.

**SECTION 2:** The rates and charges set forth in attached Rate Schedule "A" (Page 6 of 7) for a 12” non-residential potable water service shall be effective for all bills rendered by the Utilities Commission commencing with the first billing in January 2016, and thereafter until further changed or modified.

**SECTION 3:** Fire service charges of non-metered fire service lines shall be zero dollars.

**SECTION 4:** If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereof.

**SECTION 5:** All Resolutions, or portions thereof, in conflict herewith are hereby rescinded and superseded.

THE ABOVE AND FOREGOING RESOLUTION was introduced at a regular meeting of the Utilities Commission, City of New Smyrna Beach, Florida, held on December 21, 2015, by Commissioner Bohannon, who moved its adoption, which motion was seconded by Commissioner Holcomb, and upon roll call vote of the Commission was as follows:
