

RESOLUTION NO. 8-07

A RESOLUTION OF APPRECIATION FOR THE HONORABLE SERVICE OF KEVIN J. PARA AS A CHAIRMAN AND UTILITIES COMMISSIONER ON BEHALF OF THE UTILITIES COMMISSION, CITY OF NEW SMYRNA BEACH, FLORIDA, RESCINDING ALL RESOLUTIONS, OR PORTIONS THEREOF, IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Utilities Commission, City of New Smyrna Beach, Florida, was duly created and validly existing under and by virtue of Chapters 67-1754 and 85-503, Laws of Florida, as the governing body of the utility system of the City of New Smyrna Beach, Florida; and

WHEREAS, the City Commission appointed Kevin J. Para to serve as a Utilities Commissioner commencing in September 2004, and

WHEREAS, Chairman Para has provided knowledge, insight, and personal sacrifice in order to fulfill his obligations to the community in this position, and

WHEREAS, Chairman Para has introduced technology concepts and forward thinking concepts for the benefit of the community, and

NOW, THEREFORE, BE IT RESOLVED BY THE UTILITIES COMMISSION, CITY OF NEW SMYRNA BEACH, FLORIDA, AS FOLLOWS:

SECTION 1: The Utilities Commission, City of New Smyrna Beach, Florida does hereby express our appreciation to Kevin J. Para for his dedication, compassion and honorable service as a Chairman and Utilities Commissioner, commencing September 2004 to September 2007.

SECTION 2: If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereof.

SECTION 3: All Resolutions, or portions thereof, in conflict herewith are hereby rescinded and superseded.

SECTION 4: After adoption by the Utilities Commission, this Resolution shall take effect immediately upon passage.

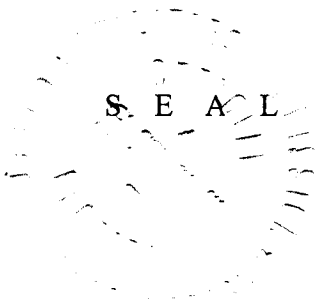
