

NOTICE OF PRELIMINARY PUBLIC HEARING

UTILITIES COMMISSION City of New Smyrna Beach, Florida

NOTICE IS HEREBY GIVEN THAT A PRELIMINARY PUBLIC HEARING WILL BE HELD AT THE UTILITIES COMMISSION, CITY OF NEW SMYRNA BEACH, FLORIDA, REGARDING PROPOSED REVISIONS FOR PUBLIC STREET LIGHTING AND PRIVATE OUTDOOR LIGHTING ELECTRIC SERVICE RATES (INCREASES) AND PROPOSED NEW ELECTRIC SERVICE RATES FOR ELECTRIC VEHICLE (E.V.) CHARGING. SAID HEARING WILL BE HELD MONDAY, JUNE 27, 2022, AT OR AFTER 3:00 P.M., AT THE UTILITIES COMMISSION OFFICE, 200 CANAL STREET, NEW SMYRNA BEACH, FLORIDA, ON THE THIRD FLOOR, IN THE DEBERRY ROOM.

A FINAL PUBLIC HEARING WILL THEN BE HELD AND THESE RATES WILL BE CONSIDERED AT THE REGULAR U.C. MEETING, FOLLOWING THE FINAL PUBLIC HEARING, ON JULY 25, 2022, ON THE THIRD FLOOR, IN THE DEBERRY ROOM AT 200 CANAL STREET, NEW SMYRNA BEACH, FLORIDA.

ALL INTERESTED PARTIES MAY APPEAR AT THE SCHEDULED PUBLIC HEARINGS AND ALSO ARRANGE TO INSPECT DOCUMENTS REGARDING THESE MATTERS AVAILABLE AT THE UTILITIES COMMISSION OFFICE AT 200 CANAL STREET, NEW SMYRNA BEACH, FLORIDA; AND ARE ALSO LOCATED ON THE U.C.'S WEBSITE – www.ucnsb.org.

PURSUANT TO SECTION 286.0105 OF THE FLORIDA STATUTES, IF AN INDIVIDUAL DECIDES TO APPEAL ANY DECISION MADE BY THE UTILITIES COMMISSION, CITY OF NEW SMYRNA BEACH, FLORIDA, WITH RESPECT TO ANY MATTER CONSIDERED AT THESE PUBLIC HEARINGS, THAT INDIVIDUAL WILL NEED A RECORD OF THE PROCEEDINGS, AND WILL NEED TO ENSURE THAT A VERBATIM RECORD OF THE PROCEEDINGS IS MADE. THE TRANSCRIPTION OF SUCH A VERBATIM WILL BE PROVIDED TO AN INDIVIDUAL AT A COST TO BE DETERMINED BY THE UTILITIES COMMISSION IN ACCORDANCE WITH THE FULL COST TO REPRODUCE SUCH TRANSCRIPTIONS AND COPIES.

IN ACCORDANCE WITH THE AMERICAN WITH DISABILITIES ACT, PERSONS WITH DISABILITIES NEEDING A SPECIAL ACCOMMODATION TO PARTICIPATE IN THESE PROCEEDINGS SHOULD CONTACT THE INDIVIDUAL OR AGENCY SENDING THE NOTICE; IF POSSIBLE, NO LATER THAN FIVE DAYS PRIOR TO THE PROCEEDING AT THE ADDRESS GIVEN ON NOTICE.
